(6990) Call to order	The second meeting of Faculty Council for the 2024-2025 academic year was called to order at 3:30 pm by Professor Shortell (SOCY).

Communications

Senior Vice President for Finance and Administration Gilbert provided updates about recommendations made by the COACHE Faculty Experience Committee, including the restoration of the cafeteria and faculty dining room and increasing food services on campus; the capital budget and current projects, the hiring of projects managers and staff to maintain, repair, and manage facilities projects, and a campus wide presentation to discuss projects in detail; the creation of a database to report facilities issues and the status of repairs; faculty and staff access to athletic facilities; and current inventories of campus space and furniture to help with planning, utilization, and repair.

Provost Bedford presented on the status of recommendations made by the COACHE Faculty Experience Committee, including the importance of the administration's listening without defensiveness to faculty input and the openness of the administration to that input; the improvement of services in the Office of Research and Sponsored Programs with the use of evaluation and staff assignments; initial research to support the development of a website for student research opportunities; raising the profile of human research protections programs to prepare student researchers through the use of BC Knowledge for Students; the formula for reassigned time for faculty with ongoing grants; the reduction in service workload disparities; the release time formula for program directors; and the convening of a faculty committee to consider mentoring for new faculty, as well as culturally and genderresponsive mentoring. The Provost then invited faculty to read The Pedagogy of Kindness with her; she has copies available in her office.

Executive Legal Counsel & Labor Designee and Interim Chief Diversity Officer Helms delivered a presentation about Title VI mandates. Included in the presentation was the scope and definition of Title VI and information about the Office of Civil Rights (OCR); and the national context of the enhanced focus on Title VI (the rising numbers of

discrimination complaints, especially from students of Jewish, Muslim, Arab, Sikh, South Asian, Hindu, Palestinian, and other ancestries). She also spoke about the June 10, 2024 voluntary resolution agreement between the OCR and CUNY to settle several cases; OCR's general concern about and definitions of "hostile environments" in higher education; and OCR's guidance for campuses to address discrimination, harassment, and "hostile environments." She then spoke about the local implications of OCR's guidance and explained campus processes to maintain compliance with Title VI.

Executive Legal Counsel & Labor Designee Helms then spoke about the status of the five recommendations for Brooklyn College's response to concerns about student behavior, including the expansion of the BEST team to include two faculty members; the automation of communication with Public Safety if there are potential safety concerns; the update of the website; the addition of faculty members to the Workplace Violence Committee; and the use of the National Behavior Intervention Team Associations' risk rubric.

A discussion ensued, at which the following issues were addressed: details about Title VI policies and procedures and their implications, the possibility of a town hall about Title VI and free speech on campus, the reassigned time formula, and the role of the PSC in potential disciplinary procedures.
